**\*\*\*PAYING YOUR TAXES BY MAIL**

I encourage you to pay by mail. It saves you time and gas – **ALL WINTER TAX PAYMENTS SHOULD BE MAILED TO RENEE PREVICH, TREASURER 8147 FORRISTER ROAD, ADRIAN, MI 49221.** Please be sure to bring or send your copy of the tax statement with payment for a stamped "PAID" receipt. Receipts will be stamped paid on the date you pay your taxes in person or the date of postmark if you mail your payment. Remember, you can get your dog license(s) from us either in person or through the mail. Make checks payable to "Rome Township". **Please send separate checks for the taxes and dog license(s).** A Dog license is \$10.00 for each dog.

**If you have questions about your tax statement, other than an address change, please contact the Township Assessor-Lenawee Co. Equalization.** The Treasurer can only change an address on a tax statement. If you want a name deleted or added you must go through proper channels at the Lenawee County Court House.

If you have issues that need to be addressed at the monthly Township Board meeting please contact the Clerk no later than the Wednesday prior to the regularly scheduled meeting date to be included on the months meeting agenda.

If you are interested in being appointed to an appointed position on one of the Board's, such as Planning or Board of Review, when an opening occurs, please contact the Township Clerk.

All Township residents are encouraged to attend the monthly meetings of both the Township Board and Planning Commission. Meeting dates are listed on the back side of this notice.

**\*\*\* SUMMER TAXES (COLLECTED BY THE LENAWEE COUNTY TREASURER)**

The County Tax is collected in the summer along with the State Education Tax. Summer Tax payments can be deferred until your winter bill is due. Please contact the Lenawee County Treasurer at 517-264-4554 for more details. **Your summer taxes will be collected by the Lenawee County Treasurer.**
