PLANNING COMMISSION MEETING MINUTES**

July 24, 2025

Rob Apoian called the meeting to order at 8:00pm. and led the Pledge of Allegiance to the flag.

ROLL CALL: Pat Bournes, Scott Peters, Rob Apoian, Matt Minnick, Kevin Fisher, Sheri Wilt and Leo Oswald were all present.

APPROVAL OF MINUTES: Leo Oswald made a motion to approve the June 26, 2025, meeting minutes. Motion seconded by Sheri Wilt; motion carried 7-0.
