

ROME TOWNSHIP PLANNING COMMISSION MEETING MINUTES

April 28, 2022

Chair, Rob Apoian, called the meeting to order at 7:00p.m. and led the Pledge of Allegiance to the flag.

ROLL CALL: Rob Apoian, Matt Minnick, Leo Oswald, Scott Peters, & Bill Millner were all present. Kevin Fisher and Pat Bournes were absent.

OTHERS PRESENT: None.

APPROVAL OF MINUTES: Leo Oswald made a motion to approve the March 24, 2022 meeting minutes, motion seconded by Bill Millner, motion carried 5-0.

APPROVAL OF AGENDA: Leo Oswald made a motion to approve the agenda for April 28, 2022, motion seconded by Scott Peters, motion carried 5-0.

Approved a resolution opposing Lenawee County using ARPA funds or delinquent tax money for funding the Phoenix Project. They also discussed steps necessary to consider raising the road assessment tax. The Township Supervisor updated the Board about internet at the Township Hall and a recent meeting the MTA put on regarding using ARPA funds.

PLANNING COMMISSION CHAIR REPORT: Chairperson Rob Apoian recommended the Township Board strongly consider installing an Automatic External Defibrillator (AED) in the Township Hall.
