PUBLIC HEARING

Public Hearing - Mr. Zellen was given the opportunity to discuss reasons why he has missed meeting and did not communicate with the Planning Commission. Mr. Zellen did not show up for this hearing. His behavior is by definition "nonfeasance".

Section 125.3301 of the Michigan Zoning Enabling Act authorizes the legislative body of a local unit of government to remove a member of a zoning commission for "nonfeasance" in office.

A motion was made by Al to remove Mr. Zellen from the position of Planning Commission Chairman, and seconded by Harvey. The motion carried.

Roll Call Vote: Al-Yes, Harvey-Yes, Jeremiah-Yes, and Wayne-Yes.

A motion was made by Al to close the public hearing, and seconded by Harvey. The motion carried.

Gilbert Hwy Primary Road - Tabled

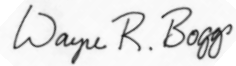
Bill Pay Procedures - Tabled, to be discussed when the treasurer is at the meeting.
