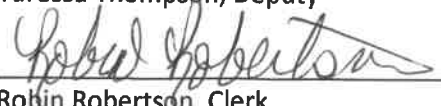

Order of Business: 1. Reviewed the topic of Marihuana Ordinances. The conversation bounced back and forth between Recreational and Medical Marihuana. The Planning Commission is in the process of reviewing an Ordinance on Recreational Marihuana which will then be brought back to the Township Board. 2. MTA online training has been paid for the year. Fire Department billing – The question has been raised if Cambridge Twp Fire Dept bills residents and or insurance companies for services provided in Rome Twp.
