Order of Business: - The Planning Commission has requested an increase of \$10.00 per meeting. Roxann made a motion, 2nd by Robin, to increase the pay by \$10 per meeting. This will equate to \$50.00 per meeting per member, and \$75.00 per meeting for the Chairperson and Secretary to be effective April 1, 2023, to begin with the new fiscal year. All in Favor, Motion Carried. - New appointments for the Planning Commission are due for the new fiscal year. Jeremiah asked for a Motion. A Motion was made by Roxann and 2nd by Leo to Appoint Pat Bournes and Bill Milner to a new 3-year term. All in Favor. Motion Carried. - Meeting did not happen yet to renew the fire contract with Cambridge Township. The contract is due to renew for the new fiscal year. This topic is tabled until the meeting takes place. - Leo brought concerns to the Board regarding past conversations on the Medical Marijuana topic. The topic did not reach closure and a couple of questions need to be sent to the attorney. Scott or Robin will contact Phil Schaedler to find answers and confirm the Township is following the legal guideline. - After multiple court dates and with a court order in hand, township representatives organized and proceeded to clean up junk vehicles at 11943 US 223, Onsted. The expense will be paid by Rome Township and then applied to the property tax of the property owner. Those involved were the Lenawee County Sherriff's Dept, American One Towing, and JVR Farms. The Board previously approved up to \$10,000.00 to clean up the public menace and eye sore which caused surrounding property owners' much grief, fearing it was bringing the neighboring property values down. This project was complete in one day. Jeremiah and Scott were present for the work at the property and Jeremiah provided an update to the much-concerned public during this meeting.
