A decision was made to have the required Policies and Procedures in place to begin the project at the new Fiscal year, April 2026. - Bill asked for a Motion to approve the Township Sign proposal for \$3,206.16. Leo made a Motion, 2nd by Roxann, All in Favor. Motion Carried - Lawn care and snow removal have been brought up multiple times. Bill has had the contact information for Larry McKown and has committed to reach out and inquire about the arrangement that has been made in the past. - Trash disposal for Hall Rentals. Twice in 2024, trash was left at the hall by renters. It's not happened since and Robin has followed up to verify the Hall has been left in proper condition. With concerns resurfacing, it may be best for someone else on the Board to handle renting the building out. In the past the Supervisor (Al Boggs) took care of Hall related items. - Fire Contract discussions. Bill will contact the Sherriff's Dept to inquire about calls in Rome Twp for the past 7 – 8 years.
